#### **ASSAY SPECIFICATIONS**

**Target**: fT3 / Free Triiodothyronine

**Synonyms**: fT3 / Free Triiodothyronine

**Specificity**: This kit is for the detection of Pig fT3 / Free

Triiodothyronine. No significant cross-reactivity or interference between fT3 / Free Triiodothyronine and analogs was observed. This claim is limited by existing techniques therefore cross-reactivity may

exist with untested analogs.

**Sample Types**: This kit is intended for use with samples such as Cell

Culture Supernatants, Plasma, Serum, and Tissue Homogenates. It has been empirically tested using

the standard supplied with the kit (typically a recombinant protein).

**Detection:** Colorimetric - 450nm (TMB)

Measurement: Quantitative

**Detection Range**: 2-32 pmol/l

Sensitivity: Typically less than 0.38 pmol/l

Performance: Intra-Assay CV (<15%); Inter-Assay CV (<15%)



for diagnostic use. This kit is not approved for use in

humans or for clinical diagnosis.

#### **ASSAY PRINCIPLE**

This assay is based on the competition ELISA principle. Each well of the supplied microtiter plate has been pre-coated with a target specific capture antibody. Standards or samples are added to the wells as well as a fixed quantity of biotin-conjugated target antigen. The antigens in the standards or samples compete with the biotin-conjugated antigen to bind to the capture antibody. Unbound antigen is washed away. An Avidin-Horseradish Peroxidase (HRP) conjugate is then added which binds to the biotin. Unbound HRP-conjugate is washed away. A TMB substrate is then added which reacts with the HRP enzyme resulting in color development. A sulfuric acid stop solution is added to terminate color development reaction and then the optical density (OD) of the well is measured at a wavelength of 450 nm ± 2 nm. The OD of an unknown sample can then be compared to an OD standard curve generated using known antigen concentrations in order to determine its antigen concentration. In contrast to typical Sandwich ELISA assays, in competition assay the greater the amount of antigen in the sample, the lower the color development and optical density reading.

#### **KIT STORAGE**

The unopened kit can be stored at 2-8°C through the expiration date. Once opened, the kit can be stored at 2-8°C for 1 month. Unused strips should be kept in a sealed bag with the desiccant provided to minimize exposure to damp air.

#### **OTHER REQUIRED SUPPLIES**

- Microplate reader with 450nm wavelength filter.
- High-precision pipette and sterile pipette tips
- Eppendorf tubes
- 37°C incubator
- Deionized or distilled water
- Absorbent paper

#### **ASSAY PLANNING**

Before using this kit, researchers should consider the following:

- 1. Read this manual in its entirety in order to minimize the chance of error.
- 2. Confirm that you have the appropriate non-supplied equipment available.
- 3. Confirm that the species, target antigen, and sensitivity of this kit are appropriate for your intended application.
- 4. Confirm that your samples have been prepared appropriately based upon recommendations (see Sample Preparation) and that you have sufficient sample volume for use in the assay.
- 5. When first using a kit, appropriate validation steps should be taken before using valuable samples. Confirm that the kit adequately detects the target antigen in your intended sample type(s) by running control samples.
- 6. If the concentration of target antigen within your samples is unknown, a preliminary experiment should be run using a control sample to determine the optimal sample dilution (see Experimental Layout and Sample Preparation).
- 7. Ensure that the kit is properly stored and do not use it beyond its expiration date.
- 8. When using multiple lots of the same kit do not substitute reagents from one kit to another. Review each manual carefully as changes can occur between lots. To control for inter-assay variability include a carry-over control sample.

#### EXPERIMENTAL LAYOUT

The following is an example of how to layout a study. A dilution series of the positive control Standard should be run in duplicate or triplicate, with the last well in each series being the negative control blank. Samples should also be run in duplicate or triplicate. Unknown samples should be run as a dilution series in order to identify the optimal dilution that produces an OD reading within the OD range of the positive control Standard dilution series.

#### SAMPLE COLLECTION

This assay is intended for use with samples such as Cell Culture Supernatants, Plasma, Serum, and Tissue Homogenates. The sample collection protocols below have been provided for your reference.

**Breast Milk** - Centrifuge samples for 20 minutes at 1000×g to remove particulates. Collect the supernatant for assaying. Breast milk often requires a dilution of about 1:500 with PBS\*.

**Cell Lysates** - Collect and pellet the cells by centrifugation and remove the supernatant. Wash the cells 3 times with PBS\*then resuspend in PBS\*. Lyse the cells by ultrasonication 4 times. Alternatively freeze the cells freeze to -20°C and thaw to room temperature 3 times. Centrifuge at 1500×g for 10 minutes at 2 - 8°C to remove cellular debris. Collect the supernatant for assaying.

Erythrocyte Lysates - Centrifuge whole blood for 20 minutes at 1000×g to pellet the cells and remove the supernatant. Wash the cells 3 times with PBS\* then resuspend in PBS\*. Freeze (-20°C)/thaw (room temperature) the cells 3 times. Centrifuge at 5,000×g for 10 minutes at 2-8°C to remove cellular debris. Collect the supernatant for assaying. Erythrocyte lysates must be diluted with Standard Dilute before running.

**Plasma** - Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 1000×g at 2–8°C within 30 minutes of collection. Collect the supernatant for assaying.

Platelet-Poor Plasma - Collect plasma using EDTA as an anticoagulant. Centrifuge samples for 15 minutes at 1000×g at 2–8°C within 30 minutes of collection. It is recommended to centrifuge samples for 10 minutes at 10,000×g for complete platelet removal. Collect the supernatant for assaying.

**Sperm and Seminal Plasma** – Allow semen to liquefy at room temperature or 37°C. After liquefaction, centrifuge at 2,000×g for 10-15 minutes. Collect seminal plasma supernatant for assaying. Wash the precipitated protein 3 times with PBS\* then resuspend in PBS\*. Lyse the cells by ultrasonication then centrifuge at 2,000×g for 10-15 minutes. Collect the supernatant for assaying.

**Serum** - Use a serum separator tube and allow samples to clot for 2 hours at room temperature or overnight at 4°C before centrifugation for

20 minutes at approximately 1000×g. Collect the supernatant for assaying.

Tissue Homogenates – Because preparation methods for tissue homogenates vary depending upon tissue type, users should research tissue specific conditions independently. The following is one example only. Rinse tissues in PBS\* to remove excess blood and weighed before homogenization. Finely minced tissues and homogenized them in 5-10mL of PBS\*with a glass homogenizer on ice. Lyse the cells by ultrasonication or freeze (-20°C)/thaw (room temperature) 3 times. Centrifuge homogenate at 5000×g for 5 minutes. Collect the supernatant for assaying.

**Urine** - Aseptically collect the first urine of the day (mid-stream), voided directly into a sterile container. Centrifuge to remove particulate matter and collect the supernatant for assaying.

Cell culture supernatants, cerebrospinal, follicular, and lung lavage fluids, saliva, sweat, tears, and other biological fluids - Centrifuge samples for 20 minutes at 1000×g to remove particulates. Collect the supernatant for assaying.

\* 1xPBS (0.02mol/L pH7.0-7.2)

#### SAMPLE COLLECTION NOTES


- LifeSpan recommends that samples are used immediately upon preparation. Alternatively, samples stored at 2-8°C should be used within 5 days. For long-term storage sample aliquots should be prepared and stored at -20°C if used within 1 month, or -80°C if used within 6 months. Long term storage can result in protein degradation and denaturation, which may result in inaccurate results.
- 2. Avoid repeated freeze/thaw cycles for all samples.
- 3. In the event that a sample type not listed above is intended to be used with the kit, it is recommended that the customer conduct validation experiments in order to be confident in the results.
- 4. Due to chemical interference, the use of tissue or cell extraction samples prepared by chemical lysis buffers may result in inaccurate results.
- 5. Due to factors including cell viability, cell number, or sampling time, samples from cell culture supernatant may not be detected by the kit.
- 6. Samples should be brought to room temperature (18-25°C) before performing the assay without the use of extra heating.
- 7. Sample concentrations should be predicted before being used in the assay. If the sample concentration is not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments.
- 8. LifeSpan is responsible for the quality and performance of the kit components but is NOT responsible for the performance of customer-supplied samples used with the kit.

#### **SAMPLE PREPARATION**

The resulting Optical Density (OD) values of your sample must fall within the OD values of the standard curve in order for the calculated antigen concentration to be accurate. In many cases samples will need to be diluted in order to lower the antigen concentration to sufficient levels. Information about antigen concentrations within various sample types may be available from the published literature; however, it is often necessary to run a dilution series of each sample type. The following will prepare sufficient volumes to run the Sample dilution series in triplicate. In the case of small volume samples, a preliminary step dilution, such as 1:5 or 1:10, can be made using PBS (0.02mol/L pH7.0-7.2) as the diluent.

\* The final dilution should always be made using the same buffer that is used to dilute the Standards, and/or generate the Standard Curve.

Running duplicate or triplicate wells for each sample is recommended.



#### STANDARD PREPARATION

In some cases the Standards supplied with this kit are pre-diluted, in which case no additional preparation is needed.

Alternatively, the following are instructions for the preparation of a Standard dilution series which will be used to generate the standard curve. The standard curve is then used to determine the concentration of target antigen in unknown samples (see the **Calculation of Results** section). The following will prepare sufficient volumes to run the Standard dilution series in duplicate. Reconstituted Standard and prepared standard dilutions should be used immediately and not stored for future use.


**Standard Stock Solution** (Detection Range Max pmol/l): Reconstitute 1 tube of lyophilized Standard with 1 ml of Sample Diluent. Incubate at room temperature for 10 minutes with gentle agitation (avoid foaming).

D1 (32 pmol/l): Pipette NaNμl of Stock Standard into NaNμl of

Sample Diluent

D2 (16 pmol/l): Pipette 50μl of D1 into 150μl of Sample Diluent
 D3 (8 pmol/l): Pipette 50μl of D2 into 150μl of Sample Diluent
 D4 (4 pmol/l): Pipette 50μl of D3 into 150μl of Sample Diluent
 D5 (2 pmol/l): Pipette 50μl of D4 into 150μl of Sample Diluent

Zero Standard (0 µg/ml): Use Sample Diluent alone



#### **REAGENT PREPARATION NOTES**

- 1. It is highly recommended that standard curves and samples are run in duplicate within each experiment.
- 2. In the case of lyophilized Standards, once resuspended, Standards should be used immediately, and used only once. Long-term storage of reconstituted Standards is NOT recommended.
- 3. All solutions prepared from concentrates are intended for one-time use. Do not reuse solutions.
- 4. Do not prepare Standard dilutions directly in wells.
- 5. Prepared Reagents may adhere to the tube wall or cap during transport; centrifuge tubes briefly before opening.
- 6. All solutions should be gently mixed prior to use.
- 7. Reconstitute stock reagents in strict accordance with the instructions provided.
- 8. To minimize imprecision caused by pipetting, ensure that pipettes are calibrated. Pipetting volumes of less than  $10\mu L$  is not recommended.
- 9. Substrate solutions are easily contaminated; sterility precautions should be taken. Substrate solutions should also be protected from light.
- 10. Do not substitute reagents from one kit lot to another. Use only those reagents supplied within this kit.
- 11. Due to the antigen specificity of the antibodies used in this assay, native or recombinant proteins from other manufacturers may not be detected by this kit.

#### **ASSAY PROCEDURE**

Bring all reagents and samples to room temperature without additional heating and mixed thoroughly by gently swirling before pipetting (avoid foaming). Prepare all reagents, working standards and samples as directed in the previous sections.

- 1. Set a blank well without any solution.
- 2. Add 50µl of **Standard** or **Sample** per well. Standards need to be run in duplicate.
- 3. Immediately add 50µl of **Biotinylated Standard** to each well (<u>not to the blank well</u>), cover with a plate sealer, gently agitate to ensure thorough mixing, and incubate for 60 minutes at 37°C.
- 4. Aspirate the liquid from each well and wash 3 times. Wash by adding approximately 200 μl of **Wash Buffer** using a squirt bottle, multi-channel pipette, manifold dispenser or automated washer. Allow each wash to sit for 10 seconds before completely aspirating. After the last wash, aspirating remove any remaining Wash Buffer then invert the plate and tap against clean absorbent paper.
- 5. Add 50µl of **HRP-Avidin Conjugate** to each well (<u>not to blank well</u>), gently agitate to ensure thorough mixing, cover with a plate sealer, and incubate for 30 minutes at 37°C.
- 6. Aspirate the liquid from each well and wash 3 times as outlined in step 4.
- 7. Add 50µl to 90µl of **Substrate** to each well (**including** the Blank well), gently agitate to ensure thorough mixing, cover with a plate sealer, and incubate for 15 minutes at 37°C. Protect from light and monitor periodically until optimal color development has been achieved.
- 8. Add  $50\mu l$  of **Stop Solution** to each well, gently tap the plate to ensure thorough mixing.
- 9. Determine the optical density (OD value) of each well immediately using a microplate reader set to 450 nm.

#### **ASSAY PROCEDURE NOTES**

- 1. **ELISA Plate**: Keep appropriate numbers of strips for 1 experiment and remove extra strips from microtiter plate. Removed strips should be placed in a sealed bag containing desiccant and stored at -20°C.
- 2. **Solutions**: To avoid cross-contamination, change pipette tips between additions of each standard, between sample additions, and between reagent additions. Also, use separate reservoirs for each reagent.
- Applying Solutions: All solutions should be added to the bottom of the ELISA plate well. Avoid touching the inside wall of the well. Avoid foaming when possible.
- 4. **Assay Timing**: The interval between adding sample to the first and last wells should be minimized. Delays will increase the incubation time differential between wells, which will significantly affect the experimental accuracy and repeatability. For each step in the procedure, total dispensing time for addition of reagents or samples should not exceed 10 minutes.
- 5. **Incubation**: To prevent evaporation and ensure accurate results, proper adhesion of plate sealers during incubation steps is necessary. Do not allow wells to sit uncovered for extended periods of time between incubation steps. Do not let wells dry out at any time during the assay. Strictly observe the recommended incubation times and temperatures.
- 6. **Washing**: Proper washing procedure is critical. Insufficient washing will result in poor precision and falsely elevated absorbance readings. Residual liquid in the reaction wells should be patted dry against absorbent paper during the washing process. Do not put absorbent paper directly into the reaction wells.
- Controlling Substrate Reaction Time: After the addition of the TMB Substrate, periodically monitor the color development. Stop color development before the color becomes too deep by adding Stop Solution. Excessively strong color will result in inaccurate absorbance readings.
- 8. **Reading**: The microplate reader should be preheated and programmed prior to use. Prior to taking OD readings, remove any

- residual liquid or fingerprints from the underside of the plate and confirm that there are no bubbles in the wells.
- 9. **Reaction Time Control**: Control reaction time should be strictly followed as outlined.
- 10. **Stop Solution**: The Stop Solution contains an acid, therefore proper precautions should be taken during its use, such as protection of the eyes, hands, face, and clothing.
- 11. **Mixing**: During incubation times, the use of a micro-oscillator at low frequency is recommended. Sufficient and gentle mixing is particularly important in producing reliable results.

To minimize external influence on the assay performance, operational procedures and lab conditions (such as room temperature, humidity, incubator temperature) should be strictly controlled. It is also strongly suggested that the whole assay is performed by the same operator from the beginning to the end.

#### **ASSAY PROCEDURE SUMMARY**

Prepare all reagents, samples and standards.

Set a Blank well without any solution.

Add 50 µl of Sample or Standard to each well.

Add 50 µl of **Biotinylated Standard** to each well (<u>not to the blank well</u>) and incubate for 60 minutes at 37°C.

Aspirate and wash 3 times.

Add 50  $\mu$ l of **HRP-Avidin Conjugate** to each well (<u>not to the blank well</u>) and incubate for 30 minutes at 37°C.

Aspirate and wash 3 times.

Add 50  $\mu$ l to 90 $\mu$ l of **Substrate** to each well and incubate in the dark for 15 minutes at 37°C.


Add 50 µl of Stop Solution.

Read within 10 minutes at 450nm.

#### **CALCULATION OF RESULTS**

Average the duplicate readings for each standard, control, and sample. Create a standard curve by plotting the mean absorbance for each standard on the X-axis against the target antigen concentration on the Y-axis and draw a best fit curve through the points on the graph. The data may be linearized by plotting the log of the target antigen concentration on the Y-axis versus the O.D. of the standards on the X-axis and the best fit line can be determined by regression analysis. The linear equation (Y = mx + b) can be used to calculate the standard curve where Y is the log of the concentration of the standard and x is the O.D. value of the standard curve must be multiplied by the dilution factor.

**Typical Data:** The following standard curve is an example only and should not be used to calculate results for tested samples. A new standard curve must be generated for each set of samples tested.



### TROUBLESHOOTING GUIDE

Poor standard curve	Inaccurate pipetting.	Check pipettes.
	Wells not completely aspirated.	Completely aspirate wells between steps.
Low signal	Too brief incubation times.	Ensure sufficient incubation time.
	Incorrect assay temperature.	Use recommended incubation temperature. Bring substrate to room temperature before use.
	Inadequate reagent volumes. Improper dilution.	Check pipettes and ensure correct preparation.
Deep color but low value	Plate reader settings not optimal.	Verify the wavelength and filter setting in the plate reader.
		Turn on and warm-up the plate reader prior to use.

## **Troubleshooting Guide (continued)**

Problem	Possible Cause	Solution
Large CV	Inaccurate pipetting.	Check pipettes.
High background	Plate is insufficiently washed.	Review the manual for proper wash. If using a plate washer, check that all ports are unobstructed.
	Contaminated wash buffer.	Make fresh wash buffer.
Low sensitivity	Improper storage of the ELISA kit.	All the reagents should be stored according to the instructions.
	Stop solution not added.	Stop solution should be added to each well before measurement.
